### Change in the receiving office for temporary entry applications from Pakistan

*Monday, February 01, 2010*

Effective Monday, 1 March 2010, temporary entry visa applications from Nationals of **Pakistan** will be processed by the Immigration New Zealand (INZ) branch in Dubai.

Applications received at the Bangkok branch from now until 1 March 2010 will continue to be processed by Bangkok, while those applicants wishing to submit visa applications after 1 March 2010 should send their applications directly to Dubai. The address for Dubai branch is:

#### Tourist / Business Visa Requirements.

- Covering letter
  - Passport copy valid for at least three months past the date you are to leave New Zealand.
  - Proof that you plan to leave New Zealand (like personal Bank Statement updated + Company + travelers' cheques + credit card copy etc.) You will also need to show us proof that you have enough money to support yourself during your stay. This means you have a minimum of: **NZ\$1000** per person per month of the visit, or **NZ\$400** per person per month if accommodation has already been paid for – we will require proof of prepayment, such as hotel prepaid vouchers.
  - If you applying for Business visa Invitation letter should be faxed directly to the Embassy in Dubai.
  - Original Ticket.
  - Hotel booking (Faxed directly to the Embassy)
  - 3 recent passport size photographs (white background-non glossy paper)

## IMPORTANT

### APPLICATION FEE:

The processing fee is a NON-REFUNDABLE must accompany all applications. You have a choice of paying either in United Arab Emirates Dirhams- Bank Draft and Cash (when paying in person) **OR** You can also pay by US Dollar- Bank Draft only. The details for each are given below:

Please ensure you have the exact cash for the fee when paying in person.

Please do not include cash money in the courier package.

Bank Drafts should be made payable to "**New Zealand Immigration Service**".

**Please note we cannot accept exchange company bank drafts.**

**AED bank drafts cannot be accepted from Egypt- Fees for Egyptian applicants sent by courier** must therefore be paid by bank draft in US dollars only.

All Bank drafts must be **drawn from a US bank**, made payable to the "**New Zealand Immigration Service**".

**Credit cards are not accepted by this office.**
